PUBLIC COMMENT:

Kathy Clark of Cannelton Road shared his frustration with a neighbor that is routinely burning and how to stop him from burning hazardous materials.

Nancy Blanchard of Little Beaver Road shared concerns about unsafe rental properties in the Township and better ways to monitor these properties.

Joe Caler of Oakdale Road inquired as to the status of some of the partially demolished properties on his road and the foreclosure status.

TOWNSHIP MINUTES:

COMMUNICATION: Township Board Chairman Mike Carreon announced that the Township has been presented with opportunities through federal funding and appropriations to plan for public water to the Industrial Park on Cannelton Road. This is in the very early phases of planning and discussions.

It was also announced that the Township was going to begin enforcing a strict no smoking policy throughout all areas of the building, including all garages.

ITEM 1: Approval of the hiring of Bill Patton for Seasonal CDL Skilled Laborer at a rate of \$18.72 per hour. Mike Carreon motioned and Greg Houlette seconded. Motion was carried.

ITEM 2: Approval of Resolution 09-2023 for the Amendments to the Township Pension Plan establishing the Township contribution will remain for non-uniform Pension Plans at 10%. Mike Carreon motioned and Greg Houlette seconded. Motion was carried.

OUTSTANDING BILLS: Mike Carreon motioned to pay the outstanding bills; Greg Houlette seconded. Motion carried.

TREASURER REPORT: Greg Houlette motioned to accept the Treasurer's report, Mike Carreon seconded to accept the treasurer's report. Motion carried.
