MINUTES OF THE DARLINGTON TOWNSHIP SUPERVISORS MEETING HELD MONDAY, OCTOBER 14, 2019

The Darlington Township Supervisors met on Monday, October 14, 2019 for their regular monthly meeting in the township municipal building at 7:00 P.M.

FIRE DEPARTMENT: Monthly report was not available.

ZONING OFFICER/ ENGINEER: Jeff Frye stated he will follow up with the resident on Black Drive concerning the fence. Rudzik Excavating, Inc. has submitted Change Order #1, in the amount of \$33,020.52, for additional work completed including exploration, hydrant and valve repairs. He submitted Rudzik Excavating, Inc's Estimate for Partial Payment #2, in the amount of \$143,039.87. He has reviewed it and recommends the Township make payment. The Supervisors have tabled that payment request until the Grant Funds become available.

ITEM #1 Brian Fredrick was present to discuss the Camper Ordinance.

Mr. Frederick currently has 19 sites on 2 lots with 2 septic holding tanks. It was stated that Mr. Frederick needs to track and report who is staying on his property. The Township will prepare a form and call Mr. Frederick when it's ready to be picked up.

Supervisors to discuss scheduling a meeting with Beaver Falls Municipal Authority concerning the Industrial Park Water system. The road has been tarred and chipped without the pot holes being repaired and there are drainage issues.
