APPROVAL OF MINUTES

REPORTS:

FIRE DEPARTMENT: Monthly Report was available.

POLICE DEPARTMENT: Monthly Report was available.

ROAD MAINTENANCE: Monthly Report was available.

ZONING OFFICER: Jeff Fye reported he has finalized the MS4 permit. He also stated he has been corresponding with Russ Newman regarding the property across from Northwestern Elementary School.

SOLICITORS: Garen Fedeles stated that Chesapeake's "Cease and Desist Order" Hearing was held at the Magistrate Office October 25, 2012. Present at the hearing were Garen Fedeles, Jeff Fye and Connie McRoberts.

Mr. Fedeles reported Judge Laughner found Chesapeake guilty and fined them \$10,000.00. He also mentioned, by law, Chesapeake has 30 days to appeal.

VISITORS COMMENTS: William Ringling was present to request an access road be placed on Highway 51 to his restaurant. The supervisors explained that Highway 51 is a State Road and that Penn Dot would have to make that determination. However, Jeff Frye stated he would assist the secretary in drafting a letter to Penn Dot stating that the township is in favor of providing crossovers to the businesses along State Route 51.
