

**MINUTES OF THE DARLINGTON TOWNSHIP
SUPERVISORS MEETING HELD MONDAY, MAY 12, 2014.**

The Darlington Township Supervisors met on Monday, May 12, 2014 for their regular monthly meeting in the township municipal building at 8:00 P.M.

Chairman, Chad Crawford called the meeting to order and opened with the Pledge of Allegiance, followed by the Lord's Prayer.

APPROVAL OF MINUTES

Chad Crawford motioned, John Nicely seconded to approve the April 14, 2014 minutes. Motion carried unanimously.

REPORTS:

FIRE DEPARTMENT: Brian Farkas stated the fire department is preparing for Darlington Days. He also mention they will be holding a fundraiser. Superior Portrait Studios will be knocking door to door in the township requesting a \$20.00 donation and in return they will receive a portrait. The proceeds will go to the fire department. Monthly report was available.

POLICE DEPARTMENT: Monthly report was available.

ROAD MAINTENANCE: Monthly report was available.

ZONING OFFICER: Zoning Officer, Jeff Frye stated he has contacted Tuboscope's District Manager regarding the noise, dust and mud on the roads. He also spoke to Tuboscope's manger, Alvin Hamilton, requesting these issues be addressed within 10 days or the township will start citing them.

ENGINEER: Jeff Frye provided to the Board preliminary drawings of the proposed pavilion.

SOLICITOR: Garen Fedeles stated he drafted an ordinance regarding a Recreational Board. Chad Crawford motioned, Shaun McRoberts seconded to approve Garen Fedeles to advertise for a Recreational Board. Motion carried unanimously.

HOST MUNICIPAL INSPECTOR: Monthly report was not available.

VISITORS COMMENTS: Visitors comments included the Tuboscope issues, road materials, “paper alleys” in the township, the status of the budget deficit and the need for additional gravel on the walking trail.
